Rent Increase Notice 2025-2026

This letter is sent on behalf of Barnsley Metropolitan Borough Council for the rent at **FULL_PROPERTY_ADDRESS**.

Please acknowledge this letter as formal notice that from Monday 7 April 2025 the rent you pay for your home will be increased. This is in line with the Government's Policy on Rent Setting for Social Housing.

The rent increase will be 2.7%, which is in line with Government formula of the September 2024 Consumer Price Index (CPI) + 1%.

Services Charges are calculated separate to the rent, which vary depending on the cost of additional facilities and services to your property and communal areas. I can confirm that service charges will also increase by 2.7% for 2025/2026.

What to do next?

Please read the important information overleaf.

If you claim Universal Credit for full/partial rent

It's **your responsibility** to report the change in your rent to the Department of Work and Pensions (DWP) on or as soon as possible after Monday 7 April 2025. Please log onto your UC Online Account and report this change.

If you claim Housing Benefit for full/partial rent

You **don't** need to report the change to your rent to the Housing Benefit department. We'll do this for you. Barnsley Council will write to you after your new entitlement has been calculated.

If you pay the full/partial rent by Direct Debit

If you're already paying by Direct Debit you **don't** need to do anything. We'll amend your Direct Debit amount to reflect your new rent charge.

If you're considering setting up a Direct Debit for future payments, please phone us on **01226 787878** and we'll set this up for you over the phone. Alternatively, you can complete a Direct Debit mandate from the Income Section on our website at www.berneslaihomes.co.uk/directdebitform

If you pay the full/partial rent by Standing Order

If you're already paying by Standing Order, please tell your bank about the new rent charge.

If you're considering setting up a Standing Order for future payments, please contact your bank and give them your 11-digit rent payment reference number and Barnsley Council's bank details which are: Barclays Bank: Sort Code 20-08-07, Account No: 83651142.
